By signing this form, the undersigned :: _____

- 1) Declares that he has carefully read the Regulations of the event in its entirety and accepted it in full and without reservation
- 2) Declares that he is fully aware of all the characteristics and specificity of the race, of the track, the difficulties and the length of the circuit, which is set in the mountains with possible difficult climatic conditions (such as, for example and not limited to, cold, wind, rain, snow, poor visibility, etc.); to be aware of the risks to his personal safety related to the competition; to be an expert in Mountain Race / Trail Running / Skyrunning / Outdoor Running competitions and aware that participating to this event requires specific preparation and a strong capacity to personal autonomy which he certifies he possesses;
- 3) He declares that he does not use doping substances and that he is in possession of a Medical Sport Clearance attesting his ability to practice sports; that he is in good health and exonerates the organizers from any responsibility resulting from the verification of the above-mentioned suitability;
- 4) He agrees to carry with him, during the entire duration of the competition, the following mandatory equipment and exempts the organizers from any accident, illness or any damage attributable to the lack of the following mandatory materials: minimum 1 liter water reserve; food reserve; a personal glass 15cl minimum, water bottles included; waterproof / thermal anorak; whistle; survival blanket; mobile phone with charged batteries (in the phonebook must be added the organizers emergency numbers and the athlete's number must not be masked); a valid identity document. He accepts the checks of the mandatory equipment that can be carried out at any time of the race, he declares to be aware that the lack of even one of the mandatory equipment in the race can determine his disqualification and he accepts the unquestionable judgment of the authority in charge of the control;
- 5) He agrees to adopt, penalty the exclusion from the event, a behavior in accordance with the principles of integrity and fairness of sporting at the time of the race and not, under any circumstances, engage in behaviors that are against the law and the rules of the regulation and that could endanger his own or others' safety; He also agrees to behave respectfully towards the environment during the race, according to the principle of "running without a trace";
- 6) He takes all responsibility both criminal and civil, even objective, consequent to his participation to the event; He declares to release the organizers from any responsibility, direct or indirect, for any material and non-material damages, even future, illnesses, and / or injuries, which he may have suffered, and / or caused, even to third parties, during the entire duration of the event and / or on the occasion and / or as a consequence of his participation to it; he releases the organizers from any liability related to theft and / or damage suffered by any of his personal belongings, whose custody, he is aware, is not ensured in any way by the organizers; and he releases the organizers from any liability for damage possibly caused by him to third parties and / or property owned by third parties.
- 7) He declares to have received and fully understood the following information ex article 13 of the Legislative Decree No. 196/2003: personal data of subscribers to the event are processed in accordance with the Legislative Decree 30th June 2003, n. 196; personal data is collected at the time of the registration and is provided directly by the interested parties; failure to provide personal data makes it impossible to accept the registration itself; the data are processed on paper and in electronic form by the organizers, for all the obligations connected to organizing the event, also in order to provide users with information on the participants and the results of the event; the same data can be communicated to employees, collaborators, companies and / or companies involved in the organization of the event and to consultants of the organizers for the mentioned purposes; in relation to any sensitive data contained therein, subscribers are required to clearly express their consent for the processing of such sensitive data; communication, and transmission of sensitive data is not envisaged.
- 8) Having acknowledged the information referred to in the above point, he authorizes the processing and communication of his personal data, for the purposes connected to the realization of the event and for the publication of the results of the race; he expresses his consent to the treatment of his data as specified in the disclosure, authorizing the sending of informative material relating to future events or various initiatives proposed by the organizers and he authorizes any photographic and cinematographic filming for the production of videos, boards, publication on print and web (including download)
